## **RREEF taps CB Richard Ellis/New England to manage 68 industrial and office properties**

According to CB Richard Ellis (CBRE), CBRE/New England has taken over as direct manager for 68 of RREEF's industrial and office properties located in Mass., N.H., Conn. and Maine.
