## **AI Education Trust board of directors names scholarship recipients**

The Appraisal Institute Education Trust board of directors approved the winners of several scholarships on Aug. 10: Minorities and Women AI Designation Scholarship, AIET Minorities and Women Education Scholarship, AIET AI Designation Scholarship, AIET Graduate Scholarship and AIET Undergraduate Scholarship.
