McCall & Almy has negotiated new terms and extended the lease for the Boston Foundation at 75 Arlington St.

The Boston Foundation and landlord came to mutually agreeable terms, which allows the Foundation to remain in the building on a long-term basis. It insures that they will remain a vital part of the Back Bay neighborhood for many years to come."
