

Cronin of Colliers International brokers \$15m sale for Sunny Delight Co.

Colliers International has brokered the sale of 20 Harvard Rd., for \$15 million. Senior vice president Robert Cronin represented the seller, Sunny Delight Beverages Co., and the buyer, a private equity firm.

Sunny Delight Beverages Co. will lease back the entire 290,000 s/f manufacturing facility for a 15-year term. Additional details of the transaction were not disclosed.

Built in 1960, 20 Harvard Rd. is a 30-acre manufacturing complex that includes office, manufacturing, R&D, water treatment and warehouse facilities located on Rte. 2A/110, and one mile from Rte. 495.

In an additional capacity, Cronin, working with executive vice president Scott Jessen of Colliers International's Dallas office, also advised Sunny Delight executives on their recent acquisition of a 450,000 s/f, former Folgers Coffee facility in Sherman, Tex.
