This new state of the art facility is not only LEED Gold certified, but is also designed to suit the unique needs of researchers and foster enhanced collaboration between the therapeutic areas. Before the completion of this project, the company's research operations were split between three US sites. This facility is the US research hub for EMD Serono, and has served to unite scientists under one roof. The design and functionality of this building will help facilitate communication among researchers, which could aid in the development of new and innovative therapies in the areas of oncology, neurodegenerative diseases and infertility.
