The ARM certification is awarded to managers of residential real estate properties who have met the Institute's rigorous requirements in the areas of professional education, examination and experience. ARM members must also abide by a rigorous Code of Professional Ethics that is strictly enforced by the Institute.

This year the issues we will bring to our Congressional Members are Multifamily and Commercial Mortgage Market Liquidity: Covered Bonds and Credit Union Lending and Taxes and Real Estate: Carried Interest and Internet Sales Tax Fairness.
