Changing of the guard at ASM: Fisher new president

On Thursday, November 14 nearly 300 ASM members and guests gathered at the spectacular State Room at 60 State St. in Boston for the Association's signature event, the ASM Biennial Dinner Gala, which featured special awards, entertainment and the election of a new slate of officers and directors to lead ASM. Richard Fisher, president of Red Wing Construction, took the helm as ASM's new president.

Fisher is joined by a team of officers including president-elect Joseph Bodio of LAN-TEL Communications; vice president Steven Kenney of N.B. Kenney Company; vice president James Miller of Salem Glass Co.; and treasurer Russell Anderson of Southeastern Metal Fabricators.

"Our association represents a multitude of specialty trades, and our board members reflect that broad expertise," said outgoing ASM president David Cannistraro, whose two-year tenure as president came to an end at the event.
