One additional note regarding both demonstration reporting options. Funds are available through the Hewitt and Hope Scholarship Funds to help offset the costs of these programs. Log onto the chapter website and review the requirements, prerequisites and fine print. I'll also note the Hewitt Fund board of directors recently voted to extend the funding program through December 2015.

Speaking of scholarship funds, I want to give an early plug for the McKenney - Kinsella Memorial Golf Outing. The event will be held at Stow Acres Country Club on September 29. Check the chapter website for details. All proceeds will benefit the John D. Hewitt and Paul Kinsella Scholarship Funds.
