\* 1700 Mineral Spring Ave., North Providence, has been sold for \$1 million for Barrett Avenue Realty Trust to K Bros. This corner location on Douglas Ave. is a mixed-use property of retail, apartments, and a gas mart.

\* 1334 Associates has leased 1334 Park Ave. in Cranston to Bowen Investment Corp. The former Tim Horton's Donut Shop has been refitted to become a Honey Dew Donuts. The ten-year-old 2,003 s/f building sits on a 21,283 s/f corner site.

\* 624 Woonasquatucket Ave., North Providence, has been sold from the St. Lawrence Church Corporation of Centerdale to Pathfinder Corporation. The former 24,000 s/f elementary school and adjacent wood frame 1,696 s/f rectory will be utilized as an adult day care center. The sale price was \$250,000.
