In addition to Gaspar, Agilis Biotherapeutics, a DNA therapeutics company in the start-up stage, leased space in the building and is already expanding due to rapid growth. Agilis Biotherapeutics was represented by Newmark's Torin Taylor.

"Each of the recently leased suites were marketed for a very brief time before capturing the attention of Adrian A. Gaspar and Agilis Biotherapeutics," said Driscoll.
