## **Baldwin, O'Neil and Flynn of Cushman & Wakefield arranges 275,800 s/f in leases at Brickstone Sq.**

Andover, MA Cushman & Wakefield has arranged 11 long-term leases totaling 275,800 s/f at Brickstone Sq., a four-building office campus located at 100, 200, 300 and 400 Brickstone Sq.
