Transportation: Surcharges will more than likely be in effect for any taxis and rideshares (i.e., Uber, Lyft, etc.) on Monday. In addition, there are several public transportation options available:

Bus Station: South Station

Subway Station: World Trade Center, South Station

Train Station: Back Bay Station, South Station

Dining: It's highly recommended to book restaurant reservations well in advance. Most restaurants in the Seaport area are within walking distance from the hotel.
