BOMA Boston Update: April Roundtable, BOMI classes and BOMA Springfest

Boston, MA On April 27th, BOMA Boston and the Energy & Environment committee presented a roundtable on Energy & Waste Audits. The event was held at BXP's Fort Point Room, at Atlantic Wharf which is a zero waste facility. The panel discussion led by Radhika Kanaskar, sustainability program lead, Federal Reserve Bank of Boston offered insight on the different types of energy and waste audits, including ASHRAE and decarbonization. Chuck Hurchalla, president, Evolution Sustainability Group; Abbey Massaro, waste reduction consultant, Center for EcoTechnology; and Rick Smith, vice president, Vicinity Energy shared expertise and how buildings can use the information collected from the audits.

BOMI Budgeting & Accounting began on April 25th and will conclude on May 25th. Budgeting & Accounting is a required class for the Real Property Administrator (RPA) designation and is designed to enable students to prepare their own building or facilities budget. Students have the opportunity to apply concepts within the real property and facilities context.
