Northborough, MA NAI Glickman Kovago & Jacobs (NAIGKJ) has recently brokered a lease transaction for Concierge Physical Therapy and a \$2.2 million sale of Zorba's Taverna.

Concierge Physical Therapy, a Sutton-based company with four locations, recently signed a lease for the last remaining 4,000 s/f space at 318 Main St., a retail building close to town center. NAI Glickman Kovago & Jacobs vice presidents, Jim Keogh and Alexis Brissette, represented Concierge Physical Therapy in the transaction. This marks the second opening for Concierge Physical Therapy
