

Sawyer Ent., JLL and Bovis Lend Lease top off \$230 million W Hotel & Residences

W Hotels Worldwide, congressman Stephen Lynch, director of the Boston Redevelopment Authority, John Palmieri, Sawyer Enterprises, Bovis Lend Lease and Ironworkers Local 7, celebrated the topping off of the new \$230 million W Hotel & Residences.

Developed by Sawyer Enterprises, the property features 235 guest rooms and 123 branded, private residences with views of the Boston Common and harbor.

Each guest room at W Boston will feature the latest in modern technology offerings, signature W brand amenities, and the W bed. Additional facilities will include a Sweat Fitness center, W Living Room and 9,800 s/f of meeting space.
