Used as a house of worship, school, auditorium, memorial center & gymnasium, this property offers expansive redevelopment potential and is ideal for adaptive reuse in a well-established urban context. Located in the heart of an urban residential district, 385 High Street benefits from proximity to community, business, residential and civic buildings (Southcoast Health's Charlton Memorial Hospital, the Bristol Probate & Family Court & Southeast Housing Court, Resiliency Preparatory Academy, Dignity Memorial Cherry Place) and to public transportation and other key amenities. Its central location allows for convenient access to area highways and City infrastructure - making it ideal for reuse as institutional, residential or mixed-use development. The large site, former use and location make it particularly well-suited for multi-family housing development, mixed use retail/residential projects, community services, religious or civic reuse or land mark adaptive reuse.

Description: Property comprises a corner lot (Locust St.) of land w/34,306 SF (+/-), improved by three interconnected buildings of more than: 30,855 SF GBA, originally built 1928, steel framed, with granite and concrete foundations, brick wall exteriors and flat tar & gravel roofing. Buildings include: a Romanesque style multi-story sanctuary of 5,542 SF (+/-) constructed of brick w/limestone trimming w/vestibule/foyer of 2,501 SF; an auditorium/gymnasium w/raised stage of about 7,614 SF; a second smaller sanctuary; library; offices; kitchen(s); bathrooms; basement; an attached multi-level building purpose built as a school of about 12,000 SF with classrooms (12), offices and bathrooms is located on the east side of the complex, east of and behind the sanctuary and auditorium/gymnasium, all accessed from multiple entrances on High and Locust Streets.
