425 Sullivan Ave. is located in a commercial zone close to Rte. 5 in South Windsor. The building, a former Gerber Scientific research and development facility, features a total of 98,000 s/f of office, flex and warehouse space on more than 30 acres.

Built in 1986, the building is fully air conditioned with ample on site parking. There is a common loading dock area with three overhead doors. Ceiling heights in the office space are 10' and the warehouse has a clear height of 12'-4". Bay sizes in the warehouse are 40' x 25'. There is 1200amp, 480/277 volt, 3 phase electrical service in the building. A recently upgraded fire alarm and wet sprinkler system protect the building.

Presently, 70,000 s/f is available for lease. There is a 20,000 s/f demised warehouse space that is available immediately. The balance of the space can be subdivided as small as 2,500 s/f and individual offices are available for lease in a section of the building. Current asking rates for the office and warehouse space are well below market. In addition to the existing building there is up to 10 acres of land, some of it directly on Sullivan Ave., available for sale or for a build to suit.

Current tenants in the building include Design Professionals, a full service engineering firm; Andor Technology, manufacturers of high performance digital cameras; and a Fortune 500 product distribution company.
